It has been found that many applications are being submitted with a request for mutual transfer between two employees giving reference to the practice followed during erstwhile Bihar State Electricity Board. It was deliberated that apart from general transfer on routine course there is always an open avenue for transfer of employees on compassionate ground, if they request with sufficient justification. The *modus operandi* of mutual transfer may lead to chaos and various irregularities in the system. Hence in the light of this fact, Board of Directors of Bihar State Power (Holding) Company Limited in its 62nd meeting held on 23.05.2018 vide its resolution No. 62 -16.01 has taken the following decision-

- (i) The extant present process of mutual transfer is discontinued.
- (ii) All the transfer of personnel shall be entertained on the basis of routine transfer process according to the transfer policy as applicable in the company.

2 This provision comes into effect from the date of issue of this order.




