Shri Suresh Prasad Pandit, Assistant Controller, Transmission Sub-Division, Begusarai has been promoted to the post of Controller vide notification no. 992 dated 31.08.2018 on the basis of Broad Sheet made available by BSPTCL and his certificate regarding Diploma in Electrical Engineering. It has come to notice that Shri Prasad has obtained Diploma in Electrical Engineering by distance mode. Accordingly he was requested to submit certificate regarding his Diploma in Electrical Engineering as to whether it was a regular course or correspondence course and also to clarify whether this course of Diploma Electrical Engineering is affiliated from AICTE or not. He appeared before GM (HR/Admin.), BSPHCL on 07.09.2018 and accepted that he has completed "Diploma in Electrical Engineering" from Institute of Advance Studies in Education Deemed University, Gandhi Vidya Mandir, Sardarshahr-331401, Rajasthan, India through distance/correspondence medium. The Diploma in Electrical Engineering obtained through distance medium from the aforesaid institute is not considerable for appointment as JEE in BSPHCL and its subsidiary companies. The Diploma in Electrical Engineering obtained through regular medium only is considered for recruitment for the post of JEE and same qualification is essential for promotion to the post of Controller. The Diploma in Electrical Engineering through correspondence mode is not considered for appointment in the company and therefore the same can not be considered for the promotion to the post of controller.

Hence it has been decided by the competent authority to cancel the promotion order of Shri Pandit issued vide notification no 992 dated 31.08.2018 with effect from the date of issue of the notification.

Accordingly notification no 992 dated 31.08.2018 is cancelled with effect from issue of the notification.
