In pursuance of Employment Notice No.03/2018 of (BSPHCL). following candidate's are provisionally appointed to the post of **Assistant** on probation for two years with effect from their date of joining (28.08.2018), subject to verification of Degree/Qualification (Educational/ Technical), Marks Sheet & Other Certificates with terms and conditions stipulated in offer of appointment and Employment Notice No. 03/2018 of BSPHCL.

1. The monthly consolidated pay will be Rs. 15,500/- (Rs. Fifteen Thousand Five Hundred) only in the Consolidated Pay Band Rs. 15,500-29,300 during first year of probation period. No other allowance will be admissible but benefits such as TA and office entitlement etc. will be provided as per company rules.



2. After successful completion of probation period of first year from the date of appointment, Regular pay in level-5 (As per 7th PRC) plus other allowances as admissible from time to time from the date of joining will be admissible, subject to satisfactory performance and conduct. If during probation, the performance is not found satisfactory, the services may be terminated.

3. As per terms and conditions of Security Bond Paper, if they leave the services of the company before completing two years of probation period, they will be liable to pay a sum of Rs. 50,000/- (Fifty Thousand) to the company and they will have to give one month prior notice before leaving the job or an amount equal to one month's salary in lieu of that.
