3) Selected candidates annexed as **Annexure –A for the post of Assistant Electrical Engineer and Annexure –E for the post of Assistant Engineer (Civil)** are requested to download their offer of appointment and come with all required papers / documents as mentioned in Para – 6. The original copy of their offer of appointment issued to them will be handed over to them at the venue of joining. The offer of appointment in the name of individual candidate will be uploaded very shortly which may be downloaded by the candidate. There will be no requirement of USER ID and Password for this.

4) The candidates, whose candidature has been kept pending is listed in **Annexure– B for the post of Assistant Electrical Engineer and Annexure – F for the post of Assistant Engineer (Civil)** are also called for reporting at the joining venue. If they submit the requisite certificates/ documents, only then they will be provided offer letter and allowed to submit their joining.

5) The candidate whose any document/ certificate is wanting as mentioned in the list is directed to submit their required documents before the joining committee. If they fail to do so, their joining will be kept pending till the submission of requisite certificates/ documents. The candidate, who submitted their provisional degree certificate in place of original degree certificates is allowed to submit his/her joining but such candidates are directed to submit their original degree certificates within 60days of joining. .

6) All the selected candidates are requested to bring the following documents/ papers in original as well as its **two sets** of self attested photocopies alongwith 2 passport size recent colour photograph -

a.	ID proof	to recognize his/her identity
b.	Matriculation Certificate/ Matriculation Mark sheet	For verification of Date of Birth.
c.	Gate Score Card	For verification of validity and marks in GATE.
d.	Final Degree Certificate & marks sheet.	For ascertaining the percentage of marks and passing of the exam.
e.	Caste certificate (for reserved category for SC/ST candidates)	For verification of their caste.
f.	Domicile certificate	For verification of being a permanent domicile/ resident of Bihar.
g.	Caste & Non Creamy layer certificate (For reserved category candidates except SC/ST)	For verification of their Caste & Non creamy layer status (the certificate must have been issued within last one year in Govt. of Bihar Format)
h.	PHP Certificate issued by the competent authority.	For verification of Physical Handicap Status.

i.	Freedom Fighter Certificate, issued by the District Magistrate of concerned District.	For verification to give the benefit of Freedom Fighter quota.
j.	Conversion Chart issued by Competent Authority.	To Calculate the percentage of marks, if CGPA / SGPA etc. awarded.
k.	Any valid document regarding approval of AICTE of the Institution from which he/she has completed his/her degree course.	
l.	An affidavit sworn in before the Executive Magistrate as mentioned in the offer of appointment letter	
m.	A medical fitness certificate granted by a Govt. Doctor not below the rank of Assistant Civil Surgeon / Medical Officer of BSPHCL	


7) Candidates, who are working in any organization, they must bring NOC issued by competent authority at the time of joining.

8) It is also to be noted that after joining, you will have to execute a bond of Rs. 50,000/- on a Rs. 100 non-judicial stamp paper to the effect that if you leave the services of the Company before completing three years of probation period, you will be liable to pay a sum of Rs. 50,000/-(Fifty thousand) to the company.

9) No separate offer letter will be sent to the selected candidates. The signed/ original offer letter will be provided at the time of their joining.

10) The candidates are informed that they must be present in person on the schedule date, place and time, before the joining committee. If they fail to come on the date and place or fail to bring all required documents / papers, their candidature may be cancelled from the provisional list and no further request shall be entertained.


Note : Every precaution has been taken in preparation of the select list, however if any mistake is found at any stage, the BSPHCL reserves the right to rectify / amend its accordingly.
