Eligibility Criteria :-

- **JE (Civil)** :- Full time 3 years Diploma in Civil from a recognized Institute/ College duly recognized by State Govt./ Central Govt. approved by AICTE.
- **Mode of selection:-** JEE/JE (Civil) will be selected on the basis of Computer Based Test (CBT).




