In pursuance of decision taken by the Board of Directors of Bihar State Power (Holding) Company Limited in its 63rd Meeting held on 07.09.2018 vide its Resolution No.63-10, sanction is hereby accorded to restructure the strength of Retained Counsels as mentioned below:-

Out of 3 (three) additional posts of Standing Counsel are sanctioned, 2 (two) posts stand filled up one by Sri Anand Kumar Ojha w.e.f. 29.12.2016 and another by Smt. Nivedita Nirvikar w.e.f. 16.08.2017. The 3 (three) additional posts are sanctioned w.e.f. 29.12.2016.
ii	Additional Standing Counsel	6	2 (two) each for SBPDCL & NBPDCCL and 1 (one) for BSPHCL and 1 (one) for BSPTCL and BSPGCL
iii	Assistant Standing Counsel	7	2 (two) each for SBPDCL & NBPDCCL as well as 1 (one) each for BSPHCL, BSPGCL and BSPTCL

2. One post of Standing Counsel each for Hon'ble Supreme Court of India, New Delhi, Jharkhand High Court, Ranchi and Calcutta High Court is also created for effective and smooth functioning of the court cases of BSPHCL and its Subsidiary Companies.

The above post of Standing Counsel for Hon'ble Supreme Court of India, New Delhi is created w.e.f. 26.09.2017 i.e. the date from which Sri Gopal Singh, Advocate has been appointed as Standing Counsel to the Bihar State Power (Holding) Company Limited and its Subsidiary Companies for the Supreme Court.

4. The scale of fee of the Retained Counsels for the Patna High Court, Patna and Jharkhand High Court, Ranchi shall also be applicable for the retained counsel of the Power Company in Calcutta High Court.

5. The scale of fee for retainership of the Standing Counsel of the Power Company in Hon'ble Supreme Court fixed at Rs.25,000/- per month w.e.f. 26.09.2017 beside the professional fee per case at the existing rate circulated vide BSPHCL Office Order No.1208 dated 26.09.2017 also stands approved.
